**ARTICLE I:** The name of the corporation shall be:

**ARTICLE VII:** The incorporator's faculties will not end with the presentation of this document.


**ARTICLE VIII:** The organization is organized exclusively for charitable, educational, religious purposes within the meaning of section 501© 3 of the Internal Revenue Code (or corresponding section of any future Federal tax code). Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (A) by a corporation / organization exempt from federal Income tax under section 501© 3 of the Internal Revenue Code (or corresponding section of any future Federal tax code) or (B) by a corporation / organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code.

**ARTICLE IX:** Upon dissolution of this corporation, assets shall be distributed for one or more exempt purpose within the meaning of section 501© 3 of the Internal Revenue Code, i.e. charitable, educational, religious or scientific or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government for a public purpose.


**ARTICLE X:** The condition and regulation of the organization will be established in the Bylaws of the organization.
