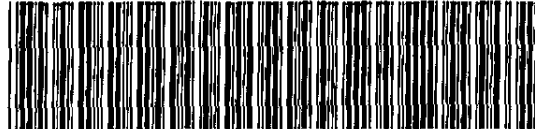

No proceeds of the corporation will enrich any individual, except that reasonable compensation may be paid for services to the corporation. If the corporation is dissolved, any assets remaining will be distributed to another corporation serving a
