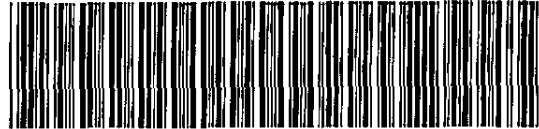

**Articles of Incorporation
of
Dayspring Outreach Ministries, Inc.
A Nonprofit Corporation**

Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the not for profit corporation law of the State of Florida, do hereby certify:

Article I

The name of the corporation shall be Dayspring Outreach Ministries, Inc.

Article II

The place in this state where the principal office of the corporation is to be initially located is 5654 Dunn Avenue, Jacksonville, FL 32218.

Article III

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code or corresponding section of any future tax code. The specific purpose of the corporation is to meet the holistic needs of the community of Jacksonville.

Article IV

The corporation shall initially have seven (7) directors. The number of directors may be increased or decreased from time to time in the manner provided in the bylaws, provided that the corporation shall never have fewer than three (3) directors. The initial directors' names and addresses are as follows:

Article V

No part of the net earnings of the corporation shall inure to the benefit of or distributable to its members, trustees, officers, or other private persons, except that the corporation

shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the provisions set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any of the provision of these articles, this corporation shall not except to an insubstantial degree, engage in any activities or exercise any powers that are not it furtherance of the purposes of the corporation.

Article VI:

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code or corresponding section of any future tax code, or shall be distributed to the federal Government, or to a State or Local government, for public purpose. Any such assets not so disposed shall be disposed of by a court of competent jurisdiction of the county in the principal office of the corporation is then located, exclusively for such purposes or to such organizations as said court shall determine, which are operated exclusively for such purposes.

Article VII:

The Registered Agent and registered office is Tara Williams, 5654 Dunn Avenue, Jacksonville, FL 32218.

Article VIII:

The Corporation shall not have members.

Article IX:


The period of duration of the corporation is perpetual.
