Article VIII - should be added as follows:

No part of the net earnings of Hooked on Life, Inc. shall inure to the benefit of, or be distributable to, any of its members, trustees, officers or other private persons, except that Hooked on Life, Inc. shall be authorized to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the exempt purposes.

Article X - should be added as follows:

Notwithstanding any other provision of these articles, Hooked on Life, Inc. shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
