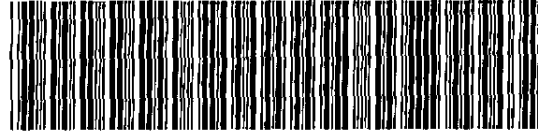

## ARTICLES OF INCORPORATION FOR

Making Others Lives Different Ministries, INC.

### ARTICLE I Name

The Name of this corporation shall be the "Making Others Lives Different Ministries", Inc., hereafter referred to as **MOLD**.

### ARTICLE II Principle Place of Business and Address

The principle office of this corporation is in Tallahassee, Florida. The mailing address of the corporation is 5003 Tennessee Capital Boulevard, Tallahassee, FL, 32303.

### ARTICLE III Purpose

This ministry is organized and shall be operated exclusively for charitable purposes as may qualify it for tax exempt status under Section 501 (c)(3) of the Internal Revenue Code of 1954, as amended, for the following purposes.

Shall fundamentally enhance and expand traditional responses of the church ministries to seek and strengthen those that are suffering, by establishing an empowering ministry. The empowering ministry will mean that:

- Individuals will gain greater knowledge of Christ while experiencing Christian growth, physical elevation, and broken hearts mended, and bodies healed through the power of prayer.
- Those incarcerated will be offered hope, encouragement and spiritual insight that will enable them to become positive individuals inside and outside of prison walls.
- The word of God will minister love, to the broke-ness and the wounded spirit collectively to sisters simultaneously.
- Individuals will have the opportunity to express themselves through Christian dance/movement in the name of the Lord.
- More trouble youth will be reached while restoring their family relationships to include morals and values. Families affected by substance abuse and HIV will receive additional support to strengthen the family and break the cycle of addiction in generations of families.
- Individuals will be feed and clothe those in need.
- Men will be strengthen through Christ, and will clearly understand their role as becoming a Man and more importantly as a Christian Man.

### ARTICLE IV Board of Directors

The Governing Board of MOLD shall be composed of both elected and appointed members. The elected members shall be the presiding officers and shall consist of a chair, vice-chair, secretary and treasurer. The elected officers, along with the Pastor of the Church ministry shall make up

the Executive Committee. Ideally, the elected officers shall be nominated from the seated Board with a term of office not to exceed two years and up to two consecutive terms. Nominations can or will be made by any appointed board member.

Appointed Board members will consist of association, organization, business, and church decision makers and shall be invited to sit on the Governing Board with the approval of the United We Stand Ministries Executive Committee. The Governing Board shall consist of not less than five nor more than twenty-five members.

The Board of Directors shall be responsible for the development, management and control of the affairs, property and funds of the corporation and shall exercise all such powers and authority as are expressly or by implication, conferred on them by these Articles of Incorporation, the by-laws of the corporation and the State of Florida.
