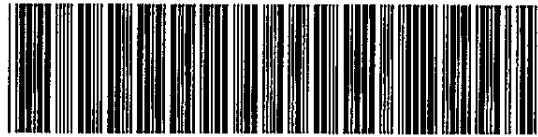

**ARTICLES OF INCORPORATION  
OF

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby act as incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the Corporation is: NORTON VINY FIREFIGHTERS CHARITABLE FUND, INC.

**ARTICLE II**

The street address of the principal office of the Corporation is: 2680 S.E. Willoughby Blvd., Stuart, Florida 34997.

The mailing address of the Corporation is: PO Box 469, Palm City, Florida 34991

**ARTICLE III**

The object and purpose of the corporation are charitable, educational, fraternal, civic and social; and other activities necessary or expedient in carrying out the charitable purpose and object of the corporation; to hold or give entertainments, solicit charitable contributions for distribution to nationally-recognized and locally-recognized bona fide charitable organizations and, in general, to do any and all things necessary to carry out and further the charitable and educational purposes and object of the corporation.

**ARTICLE IV**

The qualifications for membership in this corporation shall be as follows:

- a) The members of this corporation shall be the undersigned persons. These persons shall be entered upon the Roster of Members of this corporation without further election.
- b) Any and all active firefighters who are members in good standing of the Martin County Firefighters Association, Local 2959, IAFF, AFL-CIO, CLC.
- c) No member of the corporation who shall cease to be a member for any reason, shall be deemed to have acquired or continue to hold or maintain any right, claim or interest in and to the said corporation or any of the property, either real or personal, tangible or intangible, or otherwise acquired by this corporation by virtue of his membership in said corporation.
