Greater Tampa CERT Inc. A NON CORPORATION

1 Bette L. McCullough, the undersigned haddran person of the age of eighteen years of
older, acting as incorporator for the purpose of creating a non corporation under the laws of the State
of <u>Florida</u> as contained in
Chapter 617, F.S. (STATUE) entitled "Non Corporation Act," and
the general amendments thereto, do hereby set forth:
1. The name of the corporation is Greater Tampa CERT Inc.
2. The corporation is a <u>educational</u> (religious, charitable, etc.) corporation.
3. The purposes for which the corporation is organized are:
a. Promote emergency preparedness through training CERT.
b. Facilitate training under the CERT Program
c. Sponsor continuing education and refresher program.
d. The purpose for which <u>Greater Tampa CERT Inc.</u> is organized an
