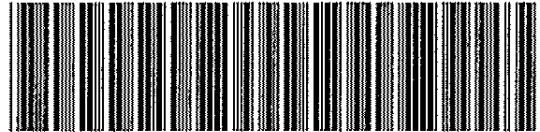

Dear Mr. Shivers:

Apparently you refused to file my articles of incorporation for the Orthodox Episcopal Church of America because my intended corporate suffix is "A Nonprofit Corporation," rather than merely "Corporation, Corp., Incorporated, or Inc." However, § 617.0401, Fla. Stat., does not require the corporate suffix to be the aforementioned terms, but rather that it must contain one of them. Specifically, it states:

A corporate name must contain the word "corporation" or "incorporated" or the abbreviation "corp." or "inc." or words or abbreviations of like import in language, as will clearly indicate


