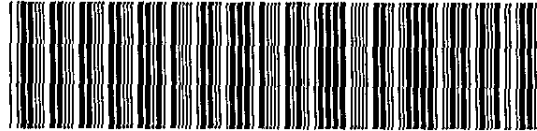

Dear Mrs. Reeves:

I am enclosing for you a package of papers and checks for the Florida Department of State in an effort to reinstate/reincorporate, whatever it is they want, our Church which was organized and has been operating since some date before 1914.

Included among the papers we are asking you to submit to the Secretary of State are the certified copies of the Circuit Court Incorporation papers and the record of the Court Order approving and accepting the same.

The Church decided that it wanted to reinstate and, I guess, that means also to reincorporate although it seems, in my opinion, to be an inconsistency between the two. Nonetheless, I have prepared all of the documents that we were able to get off the Internet in an effort to try to reinstate our non-profit corporate status and then we will go about the task of amending the charter. This will occur after we are reinstated/reincorporated, of course, and we will appreciate receiving from you any forms you have on the appropriate language to include in the amended charter to satisfy the requirements of the 501(c)(3)IRC.

We are enclosing checks to cover the Department's fees and costs and the reason for two checks for this so-called "Annual Reports" is that I don't know whether to use the table that shows a maximum of \$848.75 or to figure the amount due as beginning with the year 1993 which would add another \$132.50 to the total. This is the reason for my frustration because, had I been able to contact someone in the Department of State's office handling this sort of thing, it would have been easy to get the information, write one check, etc.

As it stands, I have little or no confidence in the Florida Department of State and therefore will greatly appreciate your assistance in seeing if we can get this charter straightened out.

Please call with any questions and do know that we do appreciate your assistance in this matter. Suddenly, there is a perceived great urgency about it all, so please do whatever you can to help expedite the matter.

TO ALL WHOM THESE PRESENTS COME, GRANTING: This is to certify that the undersigned do  
hereby associate themselves together in a corporation, not for profit, under and by virtue of the  
provisions of Section 6495 et seq., of the Compiled General Laws of Florida of 1927, and the  
several supplements and acts amendatory thereof.

FIRST: The name of the corporation shall be "Calvary Baptist Church of Daytona Beach,  
Florida"; and the location of the said corporate society shall be in Daytona Beach, Volusia  
County, State of Florida.

SECOND: The general nature of the objects of the corporation; The society is organized  
for religious purposes, viz; The worship of God, and the study of the teachings of Jesus Christ,  
and of the Baptist Belief; and to establish and maintain a place or places of worship for the  
meeting of the church, and to buy, sell, lease and hold real estate and personal property, and

to do all things incident and pertinent to such purposes, or usual to such purposes or for pecuniary profit of its members.

**THIRD:** The qualification and manner of admission of the members; Any person who has publicly confessed Jesus Christ as his or her Savior, and who has been baptized shall be qualified to become a member of the corporation. Admission to membership shall be by vote of the membership of the Church, after confession of faith, or after presentation of letter from any other Church, or after application for restoration to membership; as more specifically set forth in the by-laws of the corporation.

**FOURTH:** The corporation shall exist in perpetuity as provided by law.

**FIFTH:** The names and residence of the subscribers and incorporations are as follows:

**SIXTH:** The officers who are to manage the affairs of the corporation shall be seven deacons who shall have particular care of the spiritual affairs, and seven trustees, who shall have particular care and management of the temporal affairs, and a clerk, and a treasurer, each of whose duties shall be those prescribed in the by-laws of the corporation. The officers of the Church shall be elected at the annual meeting of the Church which shall be held on the 2nd Wednesday in October of each year. If for any unforeseen cause the annual meeting shall not be held on said day the election may be had at a special called meeting as provided in the by-laws of the Church.

**SEVENTH:** The names of the officers who are to manage all the affairs of the Church until the first election under the Charter shall be as follows;

**Deacons:** Elmer R Reid, Billie B Baggett, Daniel R Brisson, E E Burlleigh, S H Chickering, Joseph Perry, and Rollin A Williams.

**Trustees:** J Ralston Wells, Clyde A Morgan, Henry L Edwards, Jacob Achton, and Walter C Wooten.

**Clerk:** Henry L Edwards.

**Treasurer:** Daniel R Brisson.

**EIGHTH:** The by-laws of the corporation are to be made, altered, or rescinded by vote of at least two-thirds (2/3) of the members present at any annual or called meeting of the Church.

**NINTH:** The highest amount of indebtedness or liability to which the Corporation may at any time subject itself, shall be \$50,000.00 which sum shall never be greater than two-thirds (2/3) of the value of the property of the corporation.

**TENTH:** The corporation may hold real estate to the value of \$75,000.00; subject always to the approval of the circuit judge.

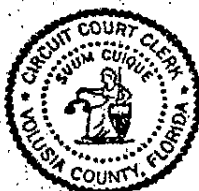
