ARTICLE I NAME

The name of the corporation shall be: Apostolic Gospel Temple, Inc.

ARTICLE III PURPOSE

The purpose of the Apostolic Gospel Temple, Inc. is to spread out the gospel of Jesus Christ by evangelizing the world unto Christ. We endeavor to provide a place of worship that will motivate and encourage one to develop and maintain a healthy relationship with God.

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 (c)(3) of the Internal Revenue Code of 1988 or the corresponding provision of any future United States Internal Revenue Law.

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or corresponding sections of any prior Or future Internal Revenue Code, or to the Federal, State, or local government for exclusive public purpose.

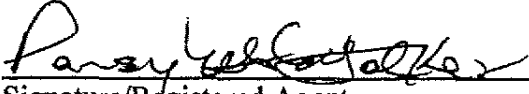

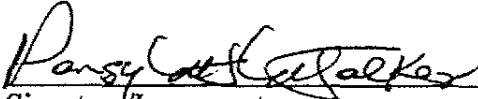
