

The bylaws of this corporation shall be made, altered and rescinded by a majority vote of the membership present and voting at any regular business meeting or at any special meeting called for that purpose.


## ARTICLE VIII

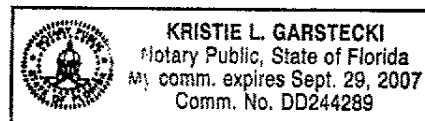
