ARTICLE V - MEMBERSHIP

5.01 The Association's Membership shall be comprised of the record owners of a fee or undivided fee interest in any Lot that is subject to the Declaration of Restrictive Covenants, Conditions, Restrictions and Easements for Majorca Palms recorded as Instrument #2008000090260 in the Public Records of Lee County, Florida, as the same may be amended from time to time. The foregoing is not intended to include persons who hold an interest merely as security for the performance of an obligation, and the giving of a security interest shall not terminate the Owner's membership. all Owners of Lots within the Summerlin Plaza subdivision

5.02 Membership shall be appurtenant to and may not be separated from ownership of any Lot which is subject to assessment by the Association.
