

We, the undersigned, hereby associate ourselves together and make, subscribe, acknowledge and file these Articles of Incorporation with the Secretary of State, of the State of Florida, for the purpose of becoming a non-profit corporation under the laws of the State of Florida. It is organized exclusively for charitable purposes to qualify as an exempt organization under Section 501(C)(3) of the Internal Revenue Code of 1986 and its regulations as they now exist or hereafter be amended.

Article I.

The name of the corporation shall be:

The JCL Cultural Foundation , Inc.

Article II.

The principal place of business of the Corporation, at least initially, shall be:

Winter Springs, Florida 32708

The principal mailing address of the Corporation, at least initially, shall be:

P.O. Box 195576
Winter Springs, Florida 32810

The Corporation shall have the power to establish branch offices and other places of business at such places within or without the State of Florida as may be determined or deemed expedient.

Article III.

The general purpose to be transacted by this corporation shall be as follows:

- (A) The Corporation is organized to support and conduct nonpartisan and nonsectarian research, educational and informational activities; to increase public awareness of diverse groups; to sponsor reports, meetings, workshop exhibitions, fairs and other educational and artistic activities of the Hispanic Culture and Arts; to educate the public about Hispanic Culture and Arts; to provide research and information to foundations and corporate giving programs about the needs of organizations that serve or advocate for disadvantaged peoples.

The forgoing paragraph shall be construed as enumerating both objects and powers of the corporations; and it is hereby expressly provided that the forgoing enumerating of specific powers shall not be held to limit or restrict in any manner the powers of this Corporation.

Article IV.

The Directors of The JCL Cultural Foundation shall be elected by the members and/or reaffirmed annually at a public meeting to be held at The JCL Cultural Foundation headquarters.

Article VI.

There shall be a Board of Directors , which shall consist of not less then three (3) and not more then five (5), the number of it to be fixed by the Board of Directors or by the Corporate By-laws. Each of the said

Directors shall be of full age and at least one shall be a citizen of The United States. A quorum for the transaction of the business shall be a majority of the Directors qualified and active and the act of majority of the Directors present at a meeting at which a quorum is present shall be the act of the Directors. Subject to the By-laws, if any, adopted by the members, the Directors may make the By-laws, and the meetings of the Directors may be held within or without the State of Florida.



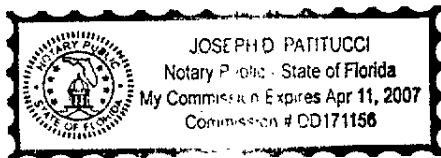
