PROPOSED ARTICLES OF AMENDMENT

The following wording is required by the Internal Revenue Service to be inserted into the Sarasota County Auxiliary Communication Services, Inc. Articles of Incorporation and adopted by the Board of Directors for the Corporation to apply for Non-Profit status under 501c (3):

1. Said (corporation/association/trust) is organized exclusively for charitable, Educational, religious or scientific purposes within the meaning of section 501C(3) of the Internal Revenue Code of 1986 (or corresponding section of any Federal tax code).
2. No part of the net earnings of the (corporation/association/trust) shall inure to the benefit of, or be distributed to, its members, trustees, directors, officers, or other private person, except that the (corporation/association/trust) shall be authorized and empowered to pay reasonable compensation for services rendered and to make payment and distributions in furtherance of section 501C(3) purposes.
3. No substantial part of the activities of the (corporation/association/trust) shall be the carrying on of propaganda or otherwise attempting to influence legislation and the (corporation/association/trust) shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.
4. Notwithstanding any other provision of these articles, the (corporation/association/trust) shall not carry on any other activities not permitted to be carried on by a (corporation/association/trust) exempt from Federal income tax under section 501C(3) of the Internal Revenue Code of 1986 (or corresponding section of any future Federal tax code).
5. Upon dissolution of the (corporation/association/trust), assets shall be distributed for one or more exempt purposes within the meaning of section 501C(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code) or shall be distributed to the Federal, State or Local Government for a public purpose.
