The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of FLORIDA Incorporation of such corporation:

#### ARTICLE 1. NAME

The name of the corporation shall be: SHEKINAH GLORY FELLOWSHIP, INC., a non-profit church (hereafter spoken of as the congregation, fellowship, or church).

#### ARTICLE 11. DURATION

The period of the duration of this corporation shall be perpetual unless dissolved in the manner prescribed according to law. The effective date of this corporation shall be August 17<sup>th</sup>, 2005.

#### ARTICLE 1V. PURPOSE
