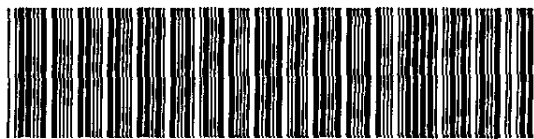

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation of such corporation:

**ARTICLE 1. NAME**

The name of the corporation shall be: SHEKINAH GLORY FELLOWSHIP, INC., a non-profit church (hereafter spoken of as the congregation, fellowship, or church).

**ARTICLE 11. DURATION**

The period of the duration of this corporation shall be perpetual unless dissolved in the manner prescribed according to law. The effective date of this corporation shall be August 17<sup>th</sup>, 2005.

**ARTICLE 111. PRINCIPAL OFFICE**

**ARTICLE 1V. PURPOSE**

The object, business and purpose of this corporation is religious, non-political, and shall be devoted to worship, instruction in the Word of God, counsel and the work of the ministry for the exercise of those spiritual gifts and offices set forth in the New Testament. Be it resolved, that we recognize ourselves as a body of Christian believers according to the scriptural plan for the local church and that we are recognized as such under the laws of the State of Florida so that we may worship God as a united body, exercising all rights and privileges granted to religious bodies. This fellowship maintains its inherent rights to sovereignty in the conduct of church life to assist in charitable work of any nature deemed beneficial to the best interests of the church and to the public as a whole, and to raise funds for carrying the same into effect in any manner allowed by the Constitution and By-Laws of this corporation.

## **ARTICLE V. MEMBERSHIP**

**Any person may become a member of the corporation in accordance with the qualifications and procedures set forth in the Bylaws of the Corporation.**

## **ARTICLE VI. MANNER OF ELECTION**

**The manner in which the Directors are elected or appointed: The Directors will hereafter be known as the Executive Board of Elders. This corporation shall be managed by the Elders of the church, appointed in accordance with the Bylaws of the corporation. This corporation will be governed by a ruling Board of Elders under the oversight of the Senior Pastor also known as the Presiding Elder.**

## **ARTICLE VII. INITIAL DIRECTORS AND/OR OFFICERS**

**This corporation shall be managed by the Elders of the church, appointed in accordance with the Bylaws of the corporation. 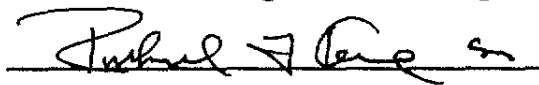
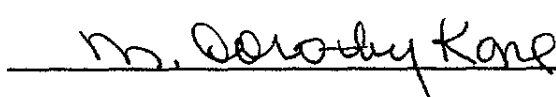

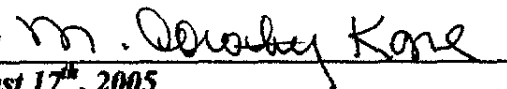
