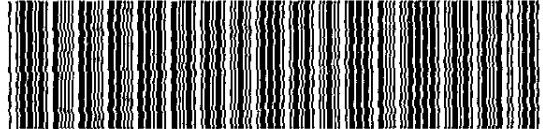

**ARTICLES OF INCORPORATION
OF
DOOR OF HOPE OUTREACH, INCORPORATED**

A Florida Corporation Not-For-Profit

ARTICLE I

The name of the Corporation ("Corporation") is:

DOOR OF HOPE OUTREACH, INCORPORATED

ARTICLE II

This Corporation is organized pursuant to "Florida Not For Profit Corporation Act" Chapter 617, Florida Statutes (1990).

ARTICLE III

The street address of the principal office of the Corporation is:

901 S. W. 18TH Street, Fort Lauderdale, Florida 33315

ARTICLE IV

The purpose for which this corporation is organized is:

(a) The Corporation is organized exclusively for charitable and educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"). No part of any net earnings shall inure to the benefit of any member, director or officer. Notwithstanding the foregoing, all employees of the Corporation are entitled to compensation, including but not limited to, salaries, bonuses and fringe benefits.

(b) Without in any way limiting the foregoing general purposes, the specific purpose of this Corporation is to conduct religious services, missionary outreach programs, and provide disaster relief to those in need.

(c) This Corporation shall have and exercise all rights and powers conferred upon corporations under the laws of the State of Florida; provided, however, that this Corporation is not empowered to engage in any activity that in itself is not in furtherance of its purpose as set forth in subparagraphs (a) and (b) of this Article IV.

ARTICLE V

This Corporation shall have perpetual existence.

ARTICLE VI

The Manner in which the directors are elected or appointed:

The powers of this Corporation shall be exercised, its properties controlled, and its affairs conducted by a Board of Directors. The Board of Directors shall be elected annually by a majority vote of the membership. The number of members of the Board of Directors and the method of election of the Board of Directors may be amended as set forth in the Bylaws.

ARTICLE VII

The initial board of directors shall consist of seven members.

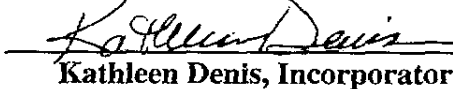
ARTICLE X
