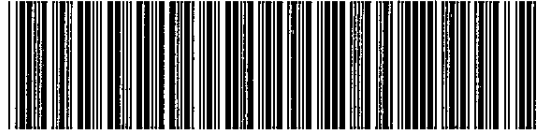

AMENDMENT TO ARTICLES OF INCORPORATION
OF
US JUDO FEDERATION-FLORIDA YUDANSHAKAI, INC

The following amendment to the Articles of Incorporation were authorized by the Board of Directors on a meeting held October 28, 2005 as follows:

ARTICLE II PRINCIPAL OFFICE

The address and mailing address of this corporation shall be:
4965 NW 186 St., Miami, Fl 33055

ARTICLE III PURPOSE

The purpose for which the corporation is organized is: To promote the social welfare, lessen neighborhood tensions, eliminate prejudice and discrimination through a healthy approach to life where sports will play a major role.

The specific purpose is to support and promote the martial arts and the sport of judo in the State of Florida. We are the association that issues memberships to all judo schools and participating students in Florida.

Notwithstanding any other provisions of these articles, the organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

No part of the net earning of the corporation shall inure to the benefit of any Director or Officer of the corporation.

Upon dissolution of the corporation, the Board of Directors shall, after paying all the liabilities of the corporation, dispose of all the assets exclusively for the purpose in such manner, or to such organizations organized exclusively for charitable, educational or religious purposes as shall at the time qualify as an exempt organization under Section 501(c)(3) of the Internal Revenue Code.

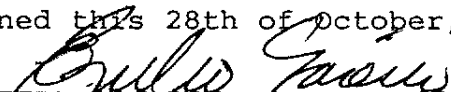
