ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF OCEAN COVE TOWNHOMES HOMEOWNERS ASSOCIATION, INC.

Pursuant to the provisions of Chapter 607, Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation, filed August 26, 2005, number _N05000008837.

- FIRST: ARTICLE IV PURPOSE AND POWERS OF THE ASSOCIATION, ITEM (h) shall be replaced with the following language:
 - (h) The association shall operate, maintain and manage the surface water or stormwater management system(s) in a manner consistent with the St. Johns River Water Management District permit no._____ requirements and applicable District rules, and shall assist in the enforcement of the Declaration of Covenants and Restrictions which relate to the surface water or stormwater management system.

The Association shall levy and collect adequate assessments against members of the Association for the costs of maintenance and operation of surface water or stormwater management system.

SECOND: **ARTICLE XI - DISSOLUTION** shall be replace with the following language:

The Association may be dissolved with the assent given in writing and signed by not less than all voting interests of the members. Upon dissolution of the Association, other than incident to a merger or consolidation, the assets of the Association shall be dedicated to an appropriate public agency to be used for purposes similar to those for which this Association was created. In the event that such dedication is refused acceptance, such assets shall be granted, conveyed and assigned to any non-profit corporation, association, trust or other organization to be devoted to such similar purposes.

In the event of termination, dissolution or final liquidation of the Association, the responsibility for the operation and maintenance of the surface water or stormwater management system must be transferred to and accepted by an entity which would comply with Section 40C-42.027, F.A.C., and be approved by the St. Johns River Water Management district prior to such termination, dissolution or liquidation.

THIRD: The amendment was adopted by the Board of Directors on the 12th day of October, 2005.
