ARTICLE III - PURPOSE OF CORPORATION

The nature of the business and the purpose for which this non-profit corporation is formed is as follows:

- 1. To provide a community based supervised indoor exercise and recreation facility for children age 13 and under.
- 2. To provide a safe, clean and stimulating environment for physically active children to play in and explore.
- 3. To prepare young minds for positive leadership by motivating them through sports to excel in academics, social development and self-awareness.
- 4. To provide a safe environment where youth can learn at an early age, the importance of health and good nutrition.
- 5. Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- 6. No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.
