**Article I Name**

The name of the corporation shall be:

**The congregation of believers shall be known as Conquerors for Christ International Ministries, Inc., ( HEREINAFTER REFERRED TO AS "CHURCH"). The Church is and shall be understood to include all related, extension and auxiliary ministries.**

**Article II Principal Office**

The principal place of business and mailing address of this corporation shall be:

**Article III Purpose**

The purpose for which the corporation is organized is:

- (A) General. This congregation is organized as a church exclusively for charitable, religious, and educational purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code of 1986, including, but not limited to, for such purposes as the establishing and maintaining of religious worship; the building, maintaining, and operating of churches, parsonages, schools, chapel, radio station, television stations, rescue missions, day-care centers (nurseries) and any other ministry that the Church may be led of God to establish, and to exercise all other powers conferred upon it by its charter or by the applicable nonprofit corporation law of the State of Florida; and all in accordance with its bylaws as the same may be hereinafter amended.**
- (B) Specific. The Church shall also ordain, license and/or commission men and women to Gospel ministry; evangelize the unsaved by the proclaiming of the Gospel of the Lord Jesus Christ; educated believers in a manner consistent with the requirements of Holy Scripture, both in Sunday and weekday schools by means of Christian education; maintain missionary activities in the United States and any foreign country; and engage in any other ministry that the Church may decide to pursue from time to time, in obedience to the will of God.**

**Article IV Manner of Election**

The manner in which the directors are elected or appointed:

**The method of election or appointment of directors shall be stated in the bylaws. The business and affairs of the Church corporation shall be managed by the Board of Trustees, whose members are referred to herein as Directors.**
