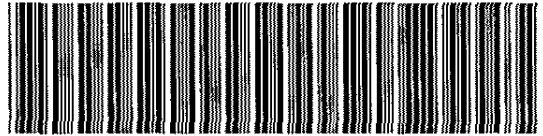

ARTICLE I
NAME

ARTICLE III
PURPOSES

- 1. Specific purpose of the corporation will be to engage in the community development projects designed to improve the quality of life of citizens domiciled within the metropolitan city of Jacksonville, Duval County, Florida.**
- 2. To engage the operation of a child care facilities.**
- 3. The purpose for which the corporation is organized are exclusively charitable and educational within the meaning of section 501 (c) (3) of the Internal revenue Code of 1986 or any corresponding**

*provision of any future United States Internal Revenue Law.
(4) To engage in any other legal business necessary to the
achievement corporate goals and objectives. .*

ARTICLE IV
DISSOLUTION CLAUSE

*upon dissolution of the corporation either as an act of law or by
resolution of the Board of Directors assets of the corporation will be
distributed to a non-profit 501 (c) (3) corporation. "However" if the
named recipient is not in existence or is no longer qualified as a
distributee, or unwilling to accept the distribution, the assets of the
organization shall be distributed to a fund, foundation, or organization
which is organized and operated exclusively for purposes specified in
section 501 (c) (3) of the Internal Revenue Code .*

ARTICLE V
LIMITATION OF POWERS

*Notwithstanding any other provision of these articles, the organization
shall not carry on any activities not permitted to be carried on by an
organization exempt from federal income tax under 501 (c) (3) of the
Internal Revenue Code of 1986 or any correspondence provision of any
United States Internal Law.*




