**ARTICLES OF INCORPORATION OF  
COALITION FOR ENVIRONMENTAL OVERSIGHT, INC.**

Pursuant to Chapter 617, Florida Statutes, the undersigned Incorporator hereby files these Articles of Incorporation to form a corporation not-for-profit under the laws of the State of Florida.

**ARTICLE I**  
**Name**

The name of the corporation is **COALITION FOR ENVIRONMENTAL OVERSIGHT, INC.**

**ARTICLE II**  
**Purpose**

The corporation shall be a corporation not-for-profit pursuant to Chapter 617, Florida Statutes. The purpose of the corporation is to further the common good and general welfare of the Tallahassee, Florida area community by promoting citizen awareness and public discourse on the economic and environmental implications of electric power supply options for the Tallahassee, Florida area and promoting responsible oversight of power supply projects in the North Florida area. The corporation may engage only in activities that may be carried on by a corporation exempt from Federal income taxes under Section 501(c)(4) of the Internal Revenue Code or any section of any statute adopted in succession thereof. No part of the net earnings of the corporation shall inure to the benefit of any member, except that the corporation may pay reasonable compensation for services rendered and may make payments or distributions in furtherance of the purposes set forth herein.
