ARTICLES OF INCORPORATION OF

THE VILLAS AT TRAMORE CONDOMINIUM ASSOCIATION, INC.

(A NON-PROFIT FLORIDA CORPORATION)

ARTICLE I.

The name of this corporation is THE VILLAS AT TRAMORE CONDOMINIUM ASSOCIATION, INC. The initial principal office of the corporation is 76 Bunker Road, Rotonda West, Florida 33947, and the mailing address of the corporation is 76 Bunker Road, Rotonda West, Florida 33947.

ARTICLE II.
