

The undersigned, acting as Incorporator of a corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I
NAME

The name of the corporation shall be SAGE MINISTRIES, INCORPORATED.

ARTICLE II
PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business of this corporation shall be 2008 58th Circle South, St. Petersburg, Florida 33712; and the mailing address shall be 4905 34th Street South, PMB #287, St. Petersburg, Florida 33711.

ARTICLE III
PURPOSE

The purposes for which the Corporation is formed and the objects to be carried on and promoted by it are as follows:


