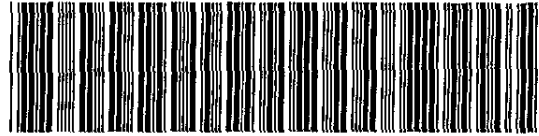



(ARTICLE I.) CORPORATE NAME

The Name of this Corporation is ***THE A.C.O.J. NEW SEASON MINISTRIES, INC.***

(ARTICLE II.) PRINCIPLE OFFICE

The Principle place of business for this corporation is 2708 East Osborne Ave

(ARTICLE III.) PURPOSE OF CORPORATION

The purpose for which this corporation is organized is to promote the teachings of the Lord Jesus Christ, and good will to all mankind. To establish and maintain a place of worship. To unite a people of like faith in the bonds of brotherly love and fellowship. To meet together to worship God in Spirit and in Truth. 


