ARTICLES OF INCORPORATION FOR HAMMOCK BAY FREEPORT MASTER ASSOCIATION, INC.

- 1. Section 6. 1 is herby amended in its entirety to read as follows:
- 6.1 <u>Membership</u>. The Members of the Master Association shall consist of the Developer under the Declaration (Freeport 860, LLC) and all of the record title owners of Lots, Units, Apartment Units and Parcels within the Property from time to time, which membership shall be appurtenant to and inseparable from ownership of the Lot, Unit, Apartment Unit or Parcel.
 - 2. Section 6.3(a)(i) is hereby amended in its entirety to read as follows:
- 6.3 <u>Classes of Members / Voting</u>. The Master Association will have four (4) classes of voting membership:
 - (a) <u>Classes of Members.</u>
- (i) <u>Class A Members</u>. Class A Members shall be all Owners of Units and Apartment Units subject to the Master Association Covenants, with the exception of the "Developer" (as long as the Class C Membership shall exist, and thereafter, the Developer shall be a Class A Member to the extent it would otherwise qualify). From and after the termination of the Class C Membership, each Class A Member shall have one (1) vote for each Unit owned by such Member and one-half (.5) vote for each Apartment Unit owned by such Member.
