PREAMBLE

The undersigned citizens of the United States, desiring to form a not for profit corporation under the Florida Not For Profit Corporation Act, Chapter 617, Florida Statutes, certify and acknowledge the following:

ARTICLE I. NAME

The name of the Corporation Not For Profit shall be SUN MASTERS SWIM TEAM, INC.

ARTICLE II. DURATION

The duration of the Corporation shall be perpetual.

ARTICLE III. PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office and mailing address of the Corporation shall be:

ARTICLE IV. PURPOSES

The Corporation is organized for the following purposes:

- 1. To promote the fitness and health of its' members through aquatic physical conditioning.
- 2. To provide coaching for its' members to develop and improve swimming and related fitness skills.
- 3. To offer its' members the opportunity to participate in fitness and/or competitive swimming programs.
- 4. To enhance fellowship and camaraderie among its' members.
- 5. To comply with the purposes relative to swimming clubs contained within Section 501(c)(7) of the Internal Revenue Code, as may be amended.

ARTICLE V. MEMBERSHIP
