

ARTICLE III – PURPOSE

The Corporation is a not for profit corporation. The purposes for which the Corporation is organized are:

- (a) A non-denominational organization to teach and minister to pastors, church leaders and laymen, locally, nationally and internationally, though evangelism, biblical philosophy and principals of the New Testament, and for other charitable purposes.
