**Articles of Incorporation
Of
International Association of Nurse Artists, Inc
A NOT-FOR-PROFIT CORPORATION**

We, the undersigned, with other persons being desirous of forming a not-for-profit corporation, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

Article I

The name of the corporation shall be:
International Association of Nurse Artists, Inc.

The address of the principal office of this corporation shall be:

Article II

Said corporation is organized exclusively for charitable, religious, educational, literary, and scientific purposes within the meaning of section 501 (c)(3) of the United States Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Code.

Notwithstanding any other provision of these articles, this corporation will not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income tax under section 501(c)(3) of the United States Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501(c)(3) and 170 (c)(2) of the United States Internal Revenue Code of 1986 or the corresponding sections of any prior or future United States Internal Revenue Code, or to the Federal, State, or local government for exclusive public purpose.

Article III

The manner in which the directors are to be elected and appointed is as stated in the bylaws.
