The undersigned, acting as incorporator of a corporation under the non-profit Corporation Act of the State of Florida, adopts the following articles of incorporation. TALLAHASSEE, FLORIDA

ARTICLE I - NAME

The name of the corporation is OAK HILL PLANTATION HOMEOWNERS ASSOCIATION, INC.

ARTICLE II - EXISTENCE AND DURATION

Existence of the Association shall commence with the filing of these Articles of Incorporation with the Secretary of State, State of Florida. The Association shall exist in perpetuity.

ARTICLE III - PURPOSES AND POWERS

The purposes for which the corporation is organized are:

- To operate OAK HILL PLANTATION HOMEOWNERS ASSOCIATION and to undertake the performance of, and to carry out the acts and duties incident to the administration of OAK HILL PLANTATION HOMEOWNERS ASSOCIATION accordance with the terms, provisions, conditions, and authorizations contained in these Articles, the By-laws of OAK HILL PLANTATION HOMEOWNERS ASSOCIATION, and the Declaration of Covenants, Conditions and Restrictions of OAK HILL PLANTATION recorded among the public records of Marion County, Florida:
- To carry out the duties and obligations given by the Declaration of Covenants. Conditions and Restrictions of OAK HILL PLANTATION recorded among the public records of Marion County, Florida; and
- To establish By-Laws and Rules Regulations for the operation of OAK HILL PLANTATION HOMEOWNERS ASSOCIATION and to provide for the formal administration of OAK HILL PLANTATION HOMEOWNERS ASSOCIATION, and to enforce the Declaration of Covenants, Conditions and Restrictions of OAK HILL PLANTATION recorded among the public records of Marion County, Florida, and the By-laws of OAK HILL PLANTATION HOMEOWNERS ASSOCIATION.

- The Association shall operate, maintain and manage the surface water or stormwater management system(s) in a manner consistent with the St. Johns River Water Management District permit number issued for Oak Hill development of the Plantation Subdivision, and the requirements contained therein, and applicable District rules, and shall assist in the enforcement of Declaration of Covenants and Restrictions which relate to the surface water stormwater management system.
- E. The Association shall levy and collect adequate assessments against members of the Association for the costs of maintenance and operation of the surface water or stormwater management system.

ARTICLE IV - MEMBERSHIP

The qualifications for members and the manner of their admission shall be regulated by the Declaration of Covenants, Conditions and Restrictions of OAK HILL PLANTATION recorded among the public records of Marion County, Florida, and the By-laws of OAK HILL PLANTATION HOMEOWNERS ASSOCIATION.

ARTICLE V - REGISTERED OFFICE

The initial registered office of the corporation shall be at 1053 Maitland Center Commons Blvd., 2nd Floor, Maitland, Florida 32751.
