ARTICLES OF INCORPORATION

Carrabelle Adopt-A-City, Inc.

A Florida Nonprofit Corporation

To Florida The undersigned, acting as the incorporator of a corporation pursuant to Chapter 61 Statutes, adopts the following Articles of Incorporation:

ARTICLE I Name

The name of the Corporation shall be: Carrabelle Adopt-A-City, Inc.

ARTICLE II Principal Place of Business and Mailing Address

The principal place of business of the Corporation shall be: 106 Avenue B South, Carrabelle, Florida 32322. The mailing address of the Corporation shall be: P.O. Box 569, Carrabelle, Florida 32322-0569.

ARTICLE III Purpose

The purpose of the Corporation is to provide assistance to certain municipalities, cities, parishes and towns, and other such governmental bodies the titles of which are not specifically enumerated herein. The aforementioned entities may or may not be located within the State of Florida. Specifically, the City of Carrabelle, Florida, may provide financial aid, supplies and other assistance to the aforementioned entities.

ARTICLE IV Manner of Appointment of Directors

Directors shall be appointed by the members of the City Commission of the City of Carrabelle, Florida, on a bi-annual basis. There shall be three (3) directors. Vacancies shall be filled at the next regularly scheduled meeting of the City Commission of the City of Carrabelle, Florida, and appointees shall serve out the unexpired term of the position. Directors may not serve for a period in excess of four (4) years.

ARTICLE V Limitation of Corporate Powers

There are no provisions which limit the corporate powers authorized under 617.0302, Florida Statutes.

ARTICLE VI Initial Registered Agent and Street Address

ARTICLE VII Dissolution

Upon dissolution of Carrabelle Adopt-A-City, Inc., assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
