**ARTICLES OF INCORPORATION
OF
THE TAVARES AFRICAN AMERICAN HERITAGE ORGANIZATION,
INC.**

**A Non-Profit Organization
Under Chapter 617, F.S., (Not for Profit)**

The undersigned, acting as "incorporators" of the organization under The Florida General Corporation Act, adopt the following Articles of Incorporation for such organization.

ARTICLE I – NAME




