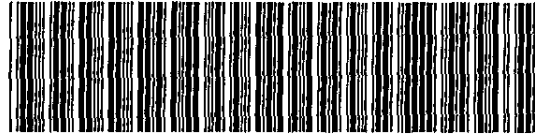


**ARTICLE VIII**
