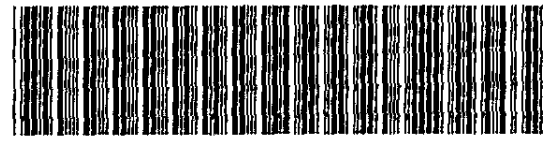

ARTICLES OF INCORPORATION

FIRST: The name of this corporation is The City of the Living God, Inc.

SECOND: Its registered office in the State of Florida is to be located at 636 39th

Street South, St. Petersburg, FL 33711, Pinellas County.

THIRD: The corporation is organized exclusively for religious purposes. The purpose of the corporation shall be to minister to the physical and spiritual needs of people, regardless of nationality or race, based on the spiritual principles, as expressed in the Holy Bible and exemplified by Jesus Christ.

FOURTH: The Board of Trustees shall manage the activities and affairs of the corporation. Trustees are selected from the membership of the corporation whenever vacancies arise based on death, resignation or removal as set forth in the Bylaws. The initial Board of Trustees shall have three (3) members whose names and addresses are as follows:



