ARTICLES OF CORRECTION FOR GRACE CHURCH OF GREATER ORLANDO, INC.

Pursuant to the provisions of Section 617.0124, Florida Statutes, Grace Church of Greater Orlando files these Articles of Correction within ten (10) days of the file date of the document being corrected.

These Articles of Correction correct Articles of Amendment to Articles of Incorporation to Grace Church of Greater Orlando, Inc., filed with the Department of State on January 27, 2006, document number (((H060000236293))).

- 1. The phrase "or shall be distributed to the federal tax code," should be deleted entirely from the second paragraph of the Amendment to Article XIII and the phrase "Court of Common Peas" in the second paragraph of the Amendment to Article XIII should be changed to "Circuit Court".
 - 2. The whole amendment, with the changes enumerated in Section 1, should read

"ARTICLE XIII ORGANIZATION AND DISSOLUTION

This corporation is organized exclusively for charitable, religious, and education including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed by the Circuit Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as such Court shall determine, which are organized and operated exclusively for such purposes."

- 3. These Articles of Correction were adopted on the 1st day of February, 2006.
- 4. These Articles of Correction were adopted by the unanimous consent of the Members.
