TO  
ARTICLES OF INCORPORATION  
FOR

*Pursuant to the provisions of Section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.*

FIRST: Amendments adopted:

Article I of The Articles of Incorporation for The Oaks at Country Place Village Condominium Association, Inc., filed with the Florida Secretary of State on September 14, 2005, is hereby amended as follows:

The name of the corporation is hereby changed to:

**THE OAKS AT COUNTRY PLACE CONDOMINIUM ASSOCIATION, INC.**

Article IV of The Articles of Incorporation for The Oaks at Country Place Village Condominium Association, Inc., filed with the Florida Secretary of State on September 14, 2005, is hereby amended as follows:

The name of the declaration is hereby changed to:

**DECLARATION OF CONDOMINIUM FOR THE OAKS AT COUNTRY PLACE  
CONDOMINIUM**

The name of the condominium is hereby changed to:

**THE OAKS AT COUNTRY PLACE CONDOMINIUM**

Article VI of The Articles of Incorporation for The Oaks at Country Place Village Condominium Association, Inc., filed with the Florida Secretary of State on September 14, 2005, is hereby amended as follows:

Section 6.2.8 is hereby deleted in its entirety and replaced with the following:

**6.2.8 Surface Water Management System.** To operate and maintain the Surface Water Management System within The Oaks at Country Place Condominium (including, without limitation, all lakes, retention areas, culverts and related appurtenances, if any) in a manner consistent with applicable SFWMD Permit requirements and applicable SFWMD rules, and to assist in the enforcement of the Declaration, as may be amended from time to time, relating to the Surface Water Management System within The Oaks at Country Place Condominium. Association shall be responsible for assessing and collecting assessments, if any, for the operation, maintenance, and repairs of the Surface Water Management System within The Oaks at Country Place Condominium.

SECOND: The date of adoption of the amendments was January 19, 2006.


