ARTICLE VIII Dissolution

In the event of dissolution, the residual assets of the organization will be distributed either to Sec. 501(c)(3) organizations providing similar community welfare programs for the Estero community or will be distributed to Lee County for the benefit of Estero. If this is not feasible then the assets will be distributed to Sec. 501(c)(3) organizations benefiting the people of Estero.
