OF THE

Article I

The name of the organization is Divine Christian Women Fellowship Ministries Inc., hereafter referred to as DCWFM

Article II

The principle mailing address of the corporation is Post Office Box 106, Quincy, Florida 32353-0106, and the initial principle physical business address is 1724 DeSaix Avenue, Tallahassee, Florida 32303

Article III

The organization/incorporation is organized pursuant to Chapter 617, F.S. provisions and Laws of Florida on the Articles of Incorporation-Nonprofit as a not for profit organization to assist the needs of women and their families; socially, economically, spiritually, physically and emotionally.

DCWF is organized and formed exclusively for charitable, religious, scientific and educational purposes, including, for such purposes, the making of distributions to non-profit organizations and assisting the needs of women and their families; socially, economically, spiritually, physically and emotionally.

No part of the net earnings of the organization/corporation shall benefit or be distributive to its members, trustees, officers, or other private persons. Except that the organization/corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose of assisting the needs of women and their families as fore stated.

Upon dissolution of the organization/corporation, assets shall be distributed to a non-profit organization deemed by the federal government or state or local government exclusively for such purposes as fore stated or to such organization or organizations.

The organization/corporation shall not issue stock.

The number of directors constituting the initial board of directors shall be three (3), volunteering to be appointed by DCWFM, Inc. to serve in this capacity.
