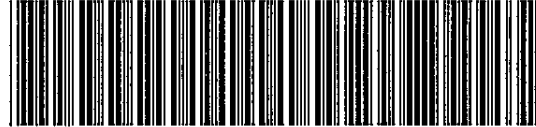

**ARTICLE I NAME**

The name of the corporation shall be First Church of Faith Ministry, Inc.

**ARTICLE II PRINCIPAL OFFICE**

The principal place of business in the State of Florida shall be 1299 Northwest 27<sup>th</sup> Avenue Pompano Beach Florida 33069.

**ARTICLE III PURPOSE**

This Corporation is a Nonprofit Public Benefit Corporation and is not organized for the private gain of any person. The Corporation is organized under the Nonprofit Public Benefit Corporation Law for, charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of Job Training, Childcare, Job Placement, Land Acquisition, Housing, Employment, Literacy, Counseling, Aids Awareness, Elderly Care and other programs to aid those in need.

**ARTICLE IV**

The duration of this corporation shall be perpetual, no stocks and shall have no partners.

**ARTICLE**

This Corporation is organized and operated exclusively for Educational and Charitable purposes within the meaning of Section 501 © (3) of the Internal Revenue Code.

Notwithstanding any other provision of the Articles, the Corporation shall not carry on any activities not permitted to carry on (1) by corporation exempt from Federal Income Tax under Section 501 © (3) of the internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

**ARTICLE VI**

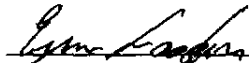
**ARTICLE IX**

Section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future Federal Tax Code, or shall be distributed to Federal Government, or to a state or local government for a public purpose. Any such asset not disposed of shall be disposed of by the Court of Common Pleas of the County in which the principal office of the organization or organizations, as said Court shall determine which are organized and operated exclusively for such purpose.
