Article of Incorporation of Responsible Dog Owner of
Miami Beach Corp.

Article of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

First: The name of the Corporation shall be Responsible Dog Owners of Miami Beach Corp.

Second: The place in this state where the principal office of the Corporation is to be located is the City of Miami Beach, Miami Dade County. The mailing address shall be:
405 North Miami Beach #104
Miami Beach, FL 33139

Third: Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Responsible Dog Owners of Miami Beach Corp. is formed to increase, promote, and teach a responsible dog ownership; to bring to the community's dog's owners a low cost or free services related with the responsibility of parenting a dog; educate dog's owners on subjects regarding a good interaction among dogs, dog's owners and the rest of the community; educate dog's owners on the laws and regulations concerning to dogs and dog ownership in the

Miami Dade County and/or other counties where the organization might be extended in the future; educate the residents on all the subjects regarding the proper way to interact with a dog in order to have a dog's bite community free and an enjoyable relation with dogs and dog's owners.

Fourth: The Directors shall be elected at the annual business meeting of the board of directors among those who have sent an application requesting to be part of the Board not before three month of the meeting or later of two month of the meeting's date. The applications shall be reviewed by the Board and accepted or refuse no later than three weeks before the meeting's date, when the applican shall be informed of the Board decision. Every Director shall have one vote.

Fifth: The names and addresses of the persons who are the initial Directors/Officers of the corporation are as follows:

Sixth: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, officers, or other private persons, except that the

corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Seventh: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.




