Articles of Incorporation of Community Life Worship Center, Inc.

The undersigned, acting as the incorporator of a corporation pursuant to Chapter 617 of the Florida Statutes, the Florida Not For Profit Corporation Act, adopts the following Articles of Incorporation for such corporation:

Article I NAME OF CORPORATION

The name of the corporation is Community Life Worship Center, Inc.

Article II PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principle place of business and mailing address of this corporation is 777 Deltona Blvd., Ste 24, Deltona, Florida 32725 Volusia County.

Article III PURPOSE

The corporation is organized exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue law), including, but not limited to, for such purposes:

- A. To organize for religious purposes, to provide a place of worship, a place of fellowship, a place of discipleship and a place of training for children, youth, parents and any and all things necessary to establish and provide a place of worship for those of faith in our Savior Jesus Christ.
- B. To ordain followers of Christ Jesus and develop and establish ministries to reach the world.
- C. Conducting a local church by the direction of the Lord Jesus Christ and under the leadership of the Holy Spirit as set forth in the Holy Bible, the irrevocable Word of God. Pursuant thereto, the following activities and guidelines shall be established:
 - 1. A recognized Creed, Code of Doctrine, discipline and form of worship shall be established.
 - 2. An ecclesiastical form of government shall be established.
 - 3. A church membership based upon acceptance of a recognized creed and belief and support of the church shall be established.

- D. To establish programs which promote wholeness for individuals, families and couples both spiritually, physically, socially and mentally.
- E. To establish and maintain other ministries which promote wholeness and Godly living to those of the world.

Article IV

MANNER OF ELECTION

This corporation shall be governed by a Board of Directors. The number of directors of the corporation shall be not less than three (3).

The Board of Directors named in Article V shall hold office until the first annual meeting of the Board of Directors to be held as prescribed in the Bylaws but in no event later than twelve (12) months from the date of incorporation, at which time an election of directors shall be held.

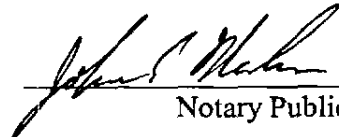

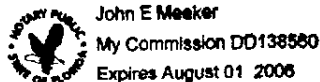
