**ARTICLES OF INCORPORATION
OF

The undersigned hereby associate themselves for the purpose of forming a corporation not for profit under the laws of the State of Florida.

ARTICLE I.

The name of the corporation shall be THE BETTER WESTSIDE PRESERVATION PROJECT, INC.

ARTICLE II.

ARTICLE III.

This corporation is organized for the purpose of educating and influencing the general public and government entities regarding the negative impact of the U. S.
