Articles of Incorporation of the undersigned, all of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

- Article I:** The name of the corporation shall be: West Boynton Lady Bandits, Inc.
- Article II:** The mailing address in this state where the principal office of the Corporation is to be located in the City of Boynton, County of Palm Beach is:
6300 Windchime Place
Boynton Beach, FL 33437
- Article III:** Said corporation is organized exclusively to foster national and international amateur sports competition, and primarily to conduct national and international competition in sports or to support and develop amateur athletes for that competition.
- Article IV:** Directors will be elected or appointed as stated in the bylaws of the corporation.
- Article V:** The names, addresses and titles of the persons who are the initial directors/officers of the corporation are as follows:

- Article VI:** The name and address of the initial Registered Agent is as follows:

- Article VII:** The name and address of the Incorporator is as follows:
Richard S. Dewalt, 6300 Windchime Place, Boynton Beach, FL. 33437
- Article VIII:** The power to adopt, alter, amend or repeal bylaws shall be vested in the Board of Directors.

Article IX: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Article X: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
