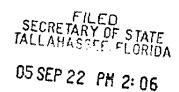

The specific purpose of the corporation is to collect and deliver disaster relief supplies and equipment to an area directly effected by a tropical storm.

Article 9: Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes whin the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or not to such organizations, as said Court shall determine, which are operated exclusively for such purposes.

**Article 11**: The period of duration of the corporation is perpetual.
