In compliance with the requirements of Florida Statues, Chapter 617, the undersigned, each a natural person competent to contract, hereby associate themselves together to form a corporation not for profit under the laws of the State of Florida.

#### **ARTICLE I**

#### NAME OF CORPORATION

The name of the corporation is THE BELLA CAVALLO FOUNDATION, INC. (hereinafter called the "Corporation").

#### **ARTICLE II**

#### PRINCIPAL OFFICE OF THE CORPORATION
