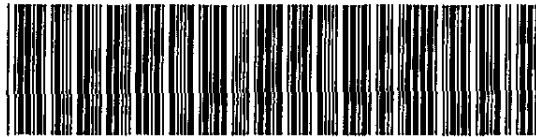

ARTICLES OF INCORPORATION**

**ARTICLE I - NAME**

The name of the corporation shall be **Sakkara Youth Institute Parent-Teacher Organization, Inc.** (hereinafter "PTO").

**ARTICLE II - PRINCIPAL OFFICE**

The principal place of business and mailing address of the PTO shall be:

**ARTICLE III - PURPOSE**

The PTO is a nonprofit organization organized to advance the education of children in Sakkara Youth Institute Independent School, Inc. within the meaning of section 501(c)(3), Internal Revenue Code. The PTO will receive, administer and utilize funds in furtherance of this purpose and, if necessary to carry out its mission, the PTO may (a) hold any property, or any undivided interest in property, without limitation as to amount or value; (b) dispose of any such property and to invest, reinvest, or deal with the principal or the income in such manner as, in the judgment of the executive board, will best promote the purposes of the PTO without limitation, except such limitations as may be contained in any applicable laws; (c) do any other act or thing incidental to or connected with the foregoing purposes or in advancement thereof, but not for the pecuniary profit or financial gain of its members, directors or officers.

**ARTICLE IV - MANNER OF ELECTION**

The general membership will elect officers by majority vote.

## **ARTICLE V - DISSOLUTION**

Upon dissolution of the PTO, all assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3), Internal Revenue Code.




