ARTICLE I. NAME

The name of this Florida not-for-profit corporation shall be:

ARTICLE III. PURPOSE

The purpose for which the corporation is organized is:

To the extent permitted by Code Section 501(c)(3), the Corporation is organized exclusively for one or more of the following purposes: arts, theatre, religious, charitable, scientific, testing for public safety, literary, or educational purposes, or to foster national or international amateur sports competition, or for the prevention of cruelty to children or animals. All references to "Code" are to the Internal Revenue Code of 1986 as amended or to corresponding provisions of future federal tax legislation.

ARTICLE IV. MANNER OF ELECTION

The manner in which the directors are elected or appointed:

The affairs of the Corporation shall be managed by a Board of Directors consisting of no less than three directors. The number of directors may be increased or decreased from time to time in accordance with the Bylaws of the Corporation, but may never be less than three. The election of directors shall be done in accordance with the Bylaws. The directors shall be protected from personal liability to the fullest extent permitted by law.

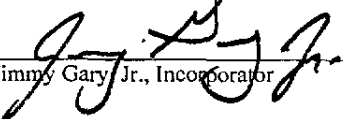

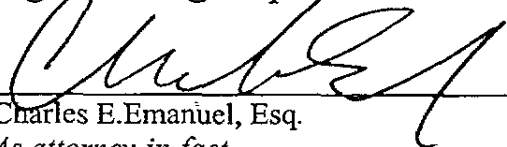
