- (h) Officers and directors shall be indemnified against expenses incurred in defense of any suit or preceding, civil or criminal, in which he is made party by reason of being a director of officer, except in relation to matters as to which he is adjudged liable for negligence or misconduct in the performance of his duties to the corporation.
