

ARTICLES OF INCORPORATION

OS SERVICES

OF

DEMOCRATIC PROFESSIONALS FORUM OF PALM BEACH COUNTY, INC

The undersigned hereby establishes the following for the purpose of becoming a nonprofit corporation under the laws of the State of Florida by and under the provisions of Chapter 617 of the statutes of the State of Florida providing for the formation, liability, rights, privileges and immunities of a corporation not for profit.

ARTICLE I

Name

The name of this Corporation (hereinafter the "Corporation") shall be DEMOCRATIC PROFESSIONALS FORUM OF PALM BEACH COUNTY, INC.

<u>ARTICLE II</u>

Principal Office

The principal place of business and mailing address of this corporation shall be: 286 Caravelle Drive, Jupiter, FL 33458.

ARTICLE III

Purpose

The corporation is organized and shall be administered and operated exclusively to operate as a political organization within the meaning of Section 527 of the Internal Revenue Code of 1986, including the following:

- (1) To engage in political activities in support of candidates and issue advocacy;
- (2) To engage in lobbying activities to the extent permitted under Section 527 of the Internal Revenue Code;

- (3) To engage in express advocacy communications;
- (4) To engage in any and all lawful activities to the foregoing purposes and as permitted for organizations qualifying as "political organizations" under Section 527 of the Internal Revenue Code except as restricted herein.

ARTICLE IV

Membership

The Corporation shall have two classes of members. Class A member(s) shall have all rights described in these Articles and the Bylaws. Class B member(s) shall have no rights other than honorary membership. The initial Class A members shall consist of Bryan S. Miller and such other persons as shall be elected to membership in the manner determined by the Bylaws of the Corporation. The directors need not be members of the Corporation unless so required by the Bylaws.

ARTICLE V

Manner of Election

The manner in which the directors are elected or appointed: The Class A member(s) have the sole ability to elect the Board of Directors. Election of the Board of Directors will occur by a majority vote of the Class A members. The Class A member(s) shall elect the Board of Directors to hold office until the next succeeding annual meeting or until successors have been elected and qualified. If Directors are not elected at the annual meeting, the incumbent Directors shall continue in office until their successors are elected and qualified.

ARTICLE VI

Names and Addresses of Directors

The names and addresses of the initial Board of Directors who shall hold office pursuant to the terms and provisions of these Articles of Incorporation and Bylaws of the Corporation shall be:
